

## VISITOR INFORMATION



Happy to have you with us in Seilpark Rigi!

Rope Park Activities hold various risks by nature. In order to provide you with major safety, we kindly ask you to carefully read through the rules and regulations and to ask our staff in case any further clarifications are needed.

## RULES AND REGULATIONS

1. Every visitor must read these rules and regulations before starting the routes. The instructions are compulsory. The custodians or supervisors responsible must explain the rules and regulations to children under 12 years of age.
2. **The minimum body height is 135 cm.** The admissible minimum weight is 20 kilos, **the maximum weight is 120 kilos.**
3. Rope park staff is only responsible for instruction, monitoring and assistance. **Each visitor takes the routes independently and at their own risk.** The park is not permanently supervised.
4. Insurance is the visitors' responsibility.
5. People suffering from physical or mental illnesses presenting a danger to their own or other peoples' health and safety are not admitted to Rigi rope park. People under the influence of alcohol, drugs or strong medication are refused access to Rigi rope Park.
6. Accessoires (Cameras, Jewellery, etc.) which can cause injuries are not allowed. Long hair should be tied up. Sports/casual wear and shoes with a good profile (good sneakers or walking boots) are recommended.
7. At every visit each visitor is obliged to attend the basic instruction course given by staff from the park. Any problems of understanding should be discussed with the rope park staff. **All staff instructions and decisions must be strictly followed.**
8. Children under 12 must be accompanied by an adult. **Per element only 1 person, per platform only 3 persons are allowed.**
9. **Visitors must be attached correctly to the safety rope on the whole route.** The official exit points (marked with EXIT) have to be used for leaving a route before finish,
10. Misusage of the emergency system leads to immediate exclusion from the rope park.
11. Rental equipment (helmet, harness, gloves etc.) must be used according to instructions for use and directives given. **The material shall be returned to the ticket office unasked after the rope park visit.** Any damage detected must be reported to rope park staff. Passing equipment on to other persons leads to exclusion from the rope park.
12. Nature and trees should be preserved. Food and drinks are strictly prohibited everywhere in the park. Smoking is prohibited everywhere in the park and in the forest. It's not allowed to abandon the hiking trails. Dogs are not allowed to walk freely.
13. There is a pick nick ground and a smoking corner at the ticket office. Any waste shall be disposed of in the designated bins.
14. Rigi rope park staff reserve the right to exclude visitors violating the rope park rules or instructions given by staff from the park.
15. The Seilpark Rigi GmbH reserves the right to close business for safety-related reasons (fire, storm, thunderstorm, bad weather etc.); no entrance fee refund will be granted in this case.
16. Seilpark Rigi GmbH refuses liability for any damage in case of disregard, evasion or violation of the rules. Any liability for damage occurring in direct or indirect connection with the use of Rigi rope park is refused.
17. The place of jurisdiction is Küssnacht, Schwyz. Swiss law is applicable.
